GZA GeoEnvironmental, Inc. (GZA), on behalf of National Grid LNG, LLC d/b/a National Grid, has prepared this letter to notify the Rhode Island Department of Environmental Management (RIDEM) Office of Land Revitalization and Sustainable Materials Management (OLRSMM) that National Grid will end all activities associated with the Short-Term Response Action Plan (STRAP) Perimeter Air Quality Monitoring (AQM) Program for the Fields Point Liquefaction Project (FPLP).

GZA initiated the Perimeter AQM program for the FPLP project in December 2018 and construction of FPLP began in early January 2019. As part of the STRAP, the AQM program was established to prevent/reduce the risk of exposure to contaminants in Site soils during the construction of the FPLP. GZA has reported the results of the Perimeter AQM program weekly to RIDEM since early January 2019. The FPLP project has completed installation of all engineered caps within the FPLP limits of work. Removal of the soil management area within the laydown area is in progress and is expected to be completed by the end of May 2022. Therefore, the Perimeter AQM program will be decommissioned accordingly. GZA intends to remove all six air monitoring stations by the end of May or middle of June 2022.

We believe the Perimeter AQM program met the intentions of the STRAP by minimizing exposure risks to on-site workers and the surrounding community and by providing an early warning of Site conditions allowing oversight personnel to proactively manage potential air quality issues.
